

Tournament Rules

- Violating tournament rules will result in automatic disqualification. Anyone who has been disqualified from a tournament will not be allowed to enter or participate in any way with the subsequent event.
- Cash prize winners will be subject to a polygraph/voice stress test

Entry Fee: \$100 per angler with a minimum \$200 boat. Children under 16 fish free

Big Fish Pot: \$10 per fisherman with \$1000 payout:

Early Bird Registration: Register before April 20th to enter your team into the early bird drawing for a chance to win free team entry into this year's tournament

GOOD SPORTSMANSHIP IS EXPECTED OF ALL INDIVIDUALS DURING THE TOURNAMENT

Any disorderly conduct will be ample reason for disqualification

Entry fees must be received via postal mail or online at www.active.com by April 27, 2013. After that date, only cash will be accepted. Registration will be accepted at the tournament site on May 5, 2013.

All State laws and regulations will be observed. Any infraction of these laws and regulations may result in disqualification. It is the responsibility of the entrant to be familiar with these laws and regulations.

1. Tournament Hours: Noon, Saturday May 4th to 2:00 PM, Sunday May 5th
2. An optional captains meeting will be held Saturday, May 4th, 10:00 a.m. at Jaycee Fairgrounds
3. All boats **must** be at weigh-in **by 2 PM on Sunday, May 5th**
4. All Fish must be caught using a handheld pole.
5. Fish must be caught on sporting tackle and be hooked and landed by the entrant only.
6. All tournament boats must maintain a distance of 50 yards between each other. Flags must be displayed while anchored. If fishing out of the boat, you must be within 150 feet of the boat.
7. A maximum of 5 fish per boat will be weighed in, only one of which can be dead. No culling of fish at weigh-in. Once a fish has been weighed and recorded, it is part of your catch. You cannot replace it with a larger fish.
8. All children under 16 MUST be accompanied by an adult.
9. No foul hooked fish will be accepted. A maximum of 3 rods per person will be allowed, or as State rules permit. However, you may have extra rods & reels in the boat.
10. Ties & disqualifications will be decided by the tournament committee.
11. All protest must be made within 30 minutes of the team's final weigh-in to the tournament weigh masters.
12. No chumming. No fishing intentionally baited holes.
13. Any fisherman with an alcohol content level high enough to affect the outcome of the polygraph test as determined by polygraph examiner and tournament committee may result in tournament disqualification.
14. All entry fees must be received by **April 27, 2013**. A fee of **\$20.00** will be applied to all entries thereafter. The tournament is limited to the first 200 boats.
15. Winners and record holders will be determined at the close of the tournament.
16. All decision made by tournament committee are final.
